



getting that number reduced to zero. It is very important each patroller is current so if your patrol representative contacts you as being delinquent, follow up immediately. It is probably a paperwork error rather than you not actually being current, but we have to get the problem solved, so help us out.

**DIVISION NEWS** – The last Southern Division Fall Officers Meeting was held August 18 & 19, 2007 in Kingsport, Tennessee. The meeting will ***no longer*** be for officers but will be a Fall Conference for ski patrollers as well as officers and instructors. This years meeting was changed in format and several programs were added for entertainment, education and to give the division a sense of our history. The instructors in the OEC Program came to the meeting and were able to attend sessions of the Board of Directors as well as take their 3-year instructor update for re-certification as OEC instructors. Thirteen proposals were introduced and passed and one of them was the change of the name of the meeting to a conference.

The meeting contained a program by Dr. Keith Argow our first Southern Division Director. He explained how the resorts began in our division, how the first patrollers arrived and how the division was carved out of the Eastern Division. **Did you know** our division ran from the Atlantic Ocean to the Mississippi River and from Florida to the border between North Carolina and Virginia? That's right, in the beginning, we did not have Virginia or West Virginia and these parts were later added to the division but we ran clear to the Mississippi River just like the original southern colonies under the British. He also presented a slide show of old photographs of the resorts and the first patrol activities as the division was being created. If you missed this event, you missed a lot.

The meeting also contained a program of comments by three NSP Board members, who attended our meeting, Barbara Dixon (Idaho), Mark Rees (North Carolina) and Larry Bost (North Carolina). These three brought us up to date on recent events at NSP and what we might expect in the near future.

The National Awards Director, Myer Avedovech, attended the meeting and gave two programs. One presentation was to the Board of Directors, Instructors and patrollers present regarding the Awards Program of the NSP. Peggy and T. Harris, our Division Awards Supervisors, also gave presentations at this part of the program.

The ***New Officers Course*** was held Sunday, after the regular meeting of the Board of Directors, and Myer was kind enough to stay over and present his second program to the division and gave special information to the new officers attending this course. This meeting was for new officers and officers that would like an update on procedures and policies regarding the administration of the division. Topics included litigation and risk management by Chuck Lollar (Division Legal Advisor) and Jim Underwood (Treasurer), financial and registration by Jim

Underwood (Treasurer & Registration Coordinator), information on the Southern Cross and how the division is now able to handle your printing needs with its new printer by Teresa Stewart (Southern Cross Editor), end of year reporting by Richard Boyer (1<sup>st</sup> ADD), awards at the patrol and division level by T. and Peggy Harris (Division Awards Supervisors) and OEC issues by Leslie Carter (Division OEC Supervisor). A lot of information, samples and handouts went to the officers to help them transition into their new jobs or upgrade their quality in proceeding with their current assignments.

Awards were presented at the Awards Banquet along with a tribute to Charles Benbow, who passed away this year and will be missed by everyone who knew him as the patroller's patroller. This year the awards were plentiful and very, very significant. A special section of the Southern Cross is devoted to this special topic.

COMMENTS FROM THE DD – This past Fall Officers Meeting gave me, your new division director, an opportunity to let you know my thoughts and goals. Here is some of what I told your Board of Directors. I will administer your division for you, but I will not make the major decisions. That belongs to the representatives appointed or elected by the patrols. Together, these patrol representatives; the regions directors and the assistants to the division director make up the delegation that decides the major issues for the division. This group is known as your Board of Directors. I, as your division director under our bylaws, do not even have a right to vote at the meeting, except to break a tie vote. That is, as it should be!

I requested the Board make some changes to help patrollers let their voices be heard in the division. One change was in the Proposal Form – to make it a little easier to read and follow as it proceeds through the voting process. Any patroller may file a proposal for consideration by the Board of Directors at any time. If filed prior to the meeting it will be presented to the Executive Committee, but that committee may only make a recommendation to the Board to approve it or not approve it. The executive committee may submit a similar version of the original proposal for approval but may not change or kill the original proposal. This is the way our division has always operated but I wanted to re-emphasize this to each patroller. Every proposal goes to the Board for a vote. Proposals may be submitted at the meeting and by-pass the Executive Committee and that was done at this past meeting.

Once a patroller has presented a proposal to the Board, the Board will either vote on it or refer it to a committee (governance, finance or programs) for study and/or they may send it to the Executive Committee for their response. After a committee has studied it and reported on it, the Board of Directors will vote on the proposal. I see my job as your division director as the person who makes sure each and every proposal gets a fair hearing. Once your Board of Directors votes on the proposal and I have received its mandate on how to administer that issue, I will proceed to

make sure the wishes of the Board are carried out. The majority rules and with this democratic process, every patroller should be able to support the division. If someone does not agree with the decision of the representative body of our division, I have no problem with that. Your job, if you continue to disagree with the vote, is to continue to try to get your message to enough patrollers and their representatives so that your side obtains the majority vote at the next meeting of the division. I will try to make sure your minority view gets a fair hearing and if the idea is a good one, I believe it will eventually prevail. When it does, I will encourage every patroller to support this idea.

Another change this year was that all proposals were made to the Board of Directors on Saturday but were not voted upon until Sunday. That gave everyone time to discuss the proposals with each other and all patrollers at the meeting. Proposals that were filed early were sent to the members of the Board of Directors early and the Executive Committee also got to view and review them early. This gives the division time to consider each issue and make good decisions for the group. When we make a less than perfect decision, it can always be returned to the delegation for consideration the next year and changed by majority vote.

In closing, I agree with our new Executive Director, Tim White. I work for you, the patroller, the resorts and the general public. My job is to insure the Southern Division serves each to the highest standard possible. I am dedicated to each patroller, to make the programs run smoothly and insure the safety of the general public. We must stay valuable to the resorts and the general public, train to the highest standard possible but the most important thing for the health of the Southern Division and the National Ski Patrol – have fun patrolling. Together, we can accomplish our goals.

## *From the Supervisors and Advisors...*

Here I sit in Tennessee in September. It was about 90 degrees today and humid, in the 80's and muggy now while I sit on my back porch and watch the moon rise. Hard to imagine that in just a few weeks, it will be snowing in the mountains and we will be back on skis and boards. I just wanted to drop a line and let you folks know what is coming down the road for the transportation program.

First, let me introduce myself. I'm Tony Tingle; I am a patroller at Hawksnest Ski Resort in Seven Devils, NC. I live in Oak Ridge, Tennessee, so I spend a lot of the winter months making the commute to the Blue Ridge Mountains. I'm a geologist in my day job. I'm married to another Hawksnest Patroller named Carla, and we have 5 dogs. I've been a patroller for over 20 years (a number that I have a hard time believing), and I have been the Division Transportation Advisor for a couple of years. I'm still figuring this position out, but I think we get a little better each season.

You are probably most familiar with your Region Transportation Advisors. They are:

- Mike Fisher - Virginia Region,
- David Cline – West Virginia Region
- Brandon Olson – Dixie Region
- David Hall – Blue Ridge Region

These guys do a lot of work for the transportation program and all deserve a pat on the back. I'm looking forward to the working with them again this season.

Now, looking ahead to when the snow flies.....

Toboggan check-off is an important beginning of the season activity. If you pull a sled during the season, it is recommended that you take a rig out for a spin, and get checked off. Different mountains have different protocols, so follow yours. Just a reminder, be safe!

Early in the season is a great time to have a Toboggan Enhancement Seminar (TES). If you need to know more about the TES, the new Transportation Manual has a course description, as does the NSP website. If those two sources don't get you the information you need, drop me an e-mail and I'll tell you what I know. I'll throw in a shameless plug for the events.....you get to spend a day with a bunch of

hands-on sled action. They are a lot of fun *and* they count as an elective for Senior. Other transportation program courses that can be taught during the season include: *Skiing Enhancement Seminars, Snowboard Enhancement Seminars, and Ski Trainers Workshops*. All are a lot of fun; see your local transportation instructor, Region Transportation Advisor, or me for more info.

If you have indicated an interest in becoming a transportation instructor during your instructor development class, I'll be sending out e-mails to you, your Patrol Reps and Region Transportation Advisors and let them know that we need to line you up with a mentor. There are some folks out there that indicated an interest last season and I didn't get a mentor assigned, for that I apologize, and you will be hearing from me this fall. Anyone interested in becoming a transportation instructor, I encourage you to hop in the program. You need to take an instructor development (ID) class, if you don't have it already. Once you have the ID class, and let someone (e.g. Patrol Rep, Region Transportation Advisor, or Me) know you have an interest, you will then be assigned a mentor. A mentor is a transportation instructor that will work with you on your toboggan teaching skills. Once your mentor thinks you are ready to get evaluated by an instructor trainer (IT) they will get in touch with an IT to come observe your teaching skills. If all goes well and you demonstrate good transportation teaching skills we get you set up as a transportation instructor.

I look forward to skiing with you this winter. Have a safe fall.

### Southern Division Telecommunications

I hope everyone is enjoying a great summer and all is well. It is fall 2007, and ski season and patrolling will be here in a "skinny minute"; so, you may be wishing, 'I sure would like a new radio!'

One of my jobs as your Southern Division Telecommunications advisor is to find FCC acceptable radios that are reasonable in price, and function well on the slopes. Well, you might have found a cheap radio that may be better than the expensive radios; but first, you need to know that all transceivers used in the US must be a type that is acceptable to the Federal Communications Commission (FCC). This acceptance is usually indicated by an id number on the radio. For example, I found a very reasonably priced radio called the Puxing PX-777 radio and it has a FCC id = *UBYQZPuxing02*.

You can find out if a radio is an acceptable type by going on the FCC internet site and doing the following:

1. Type in the FCC address [www.fcc.gov](http://www.fcc.gov) then press enter
2. Click on "Search" at the top of the page
3. Scroll down to "FCC ID Number Search;" then, left click
4. In the third line down (Applicant Name) type in the name of the applicant (for example; puxing)
5. Scroll down to the bottom; then, click on "start search"
6. After a moment or two the information should come up.

I have to thank my fellow patrollers at Hawksnest who put me onto finding these cheaper radios. You can find these radios by going to the Ebay internet cite; then, search for "Puxing." Most likely you will get several hits for Puxing. Browse around and you will most likely find a Puxing VHF radio for about \$50 plus shipping. I think the high shipping amount is a rip-off; but, is still cheaper that the \$300 to \$500 type radios.

Some of the specifications for the VHF radio are as follows:

1. Transmit power = 5 watts
2. Receive sensitivity = .2 uwatts/12 db sinad
3. Both broadband (25 MHz) and narrow band (12.5 MHz)  
(this is important if you are using a narrow band repeater)
4. A Li-ion battery that lasts me 3 days on one charge under normal use.
5. 118 channels
6. Lots of other bells and whistles

7. Optional speaker/mic
8. Optional program cable plus software to program the radio with a computer.  
(you can also program the radio manually---good luck)
9. Very small size (about the size of a regular pack of cigarettes)

There are other radios from China (I think made in the same factory) with names like the following:

1. Quanzhou
2. Licheng (who knows what other names)

If you would rather me deal with the radio dealers, I can provide you a new radio, drop in charger, speaker mic, and programmed for about \$100.00 plus shipping. If you need more information, please contact me.

Now is a great time to prepare your radio for patrolling use. My suggestions are as follows:

1. Clean exterior of radio.
2. Open the battery compartment, take the battery out, look for corrosion; then, clean the battery compartment and the battery contacts.
3. Put battery back in the radio if it is not corroded; then, recharge the radio for 14 hours.
4. Cycle the radio by turning on for 8 hours; then, recharge back up for 10 hours.
  1. If the radio does not work OK, take it to a repair shop now, before the season starts. This gives the technicians time to order and receive parts and fix the radio to like new condition.
  2. Take the radio to someone who is certified to check the key operating parameters to verify that the radio is operating in accordance with the FCC rules and regulations Part 90, para. 201-217. You are still required to have the primary operating parameters to be in tolerance. If there is an incident involving your radio and found to be negligent in maintaining those parameters; then, you are responsible. (The primary operating parameters are as follows: frequency tolerance, spurious radiation, modulation, and power output.)

The operating requirements and procedures can be found in the FCC rules and regulations Part 90 para.401-449. A brief summary proper radio communications and operations are as follows:

1. Never use profanity or improper communications on the air.
2. Never interfere with other users of the frequency. (example, Rescue and EMS
3. units, ambulances, law enforcement, etc. This is the quickest way to get a pink slip from the FCC.)
4. Identify yourself by saying your call letters at the end of your conversation or every 30 minutes, whichever comes first.
5. Post a copy of your FCC license in the patrol room.

6. Be responsible to clean and recharge the radio after use.

One can use the NSPS frequencies during training, examinations, searches, intra-communications with other patrols, rescue and search teams, or anything in the special emergency realm. If you are using the Ski Areas' frequencies, I suggest you post a copy of the Ski Areas' license close to your base radio; so, there is no question about frequency authorization and use.

One of my goals this year is to visit as many ski areas as possible. I will bring my test equipment; and (time permitting) I will be happy to check as many radios as possible.

SOUTHERN DIVISION PATROLLER SURVIVES NUCLEAR EXPLOSION

It was very dark in the Nevada dessert. The tent city was quiet with a few scientists and security guards moving about. The cooks were the first to begin the day followed later by transportation staff and officers. Prior to dawn, the entire camp was awakened, fed and moved out to the testing site. Harry Stowe of the United States Air Force was to arrive at a point in the desert for a date that would make such an impression on him, he would be able to recount the event after fifty years with clarity and detail to his fellow patrollers at the Southern Division Fall Officers Conference in Kingsport, Tennessee on Sunday, August 19, 2007.

Members of the Southern Division awaited his account with anticipation. Not the intense anticipation Harry had felt on that morning some 50 years ago when he was about to face a nuclear explosion of 40 kilotons from a distance of only 4,000 yards. But we could hardly wait for Harry to start his part of the program. Then, as he started his talk, not a sound could be heard in the room except the soft voice of Harry Stowe.

He began with a brief history of the development of the atomic bomb during World War II and how he had received a short course on nuclear warfare from the United States Air Force. He told us how he had taken a non-descript course. Then, a couple of years later, he received orders to report to Nevada to participate in a nuclear bomb test. "I had no idea why they picked me, other than I had that one class in the military on the subject" Harry stated to the group of patrollers. I found myself in the desert, in this tent city with a whole bunch of other military personnel and there I was.

The Nevada test site conducted from 90 to 100 atmospheric explosions of nuclear bombs from 1951 until 1962. The clouds and explosions became a tourist attraction for Las Vegas, since the events could be seen from the city, which was about 100 miles from most of the tests. Harry was not exactly a tourist, he got to see the cloud and explosion, but it was not at a distance of 100 miles. It was not at a distance of 50 miles or 10 miles. He got a front row seat, courtesy of the United States Air Force and he was only 4,000 yards from the bomb itself.

He told us how the early bombs were very heavy. They had lead shielding around the nuclear material. That made the bomb about 6 feet wide, 12 to 15 feet long and very heavy. They put it up in a tower. They told us the lead shielding would stop

about 1/2 of the radiation from getting to the workers on the bomb. We really did not want to get any closer to it than we had to get.

The morning of the test we found ourselves in the desert behind a slit trench. It was about two feet wide and five feet deep. They had taken the dirt out of the trench and threw it up on the side facing the tower. "I thought that was good of them to put it on the side nearest the bomb," Harry said, "I wanted all the protection I could get." He explained how he could see the tower in the distance with the light blinking on top. It was about 4,000 yards away and the only thing between that tower and me was flat dessert. There were parked, military vehicles in front of us and behind us of various types. Live animals of various types were in cages placed around us, both in front of the trench and behind it. There were some trees behind the trench at some distance from us and we waited for the officers to tell us what to do.

We had been told after we got to the trench, prior to the blast we would climb down into the trench. When given the word we would crouch down and first a typical bomb would be detonated, which contained TNT. Then the atom bomb would be exploded. We were warned not to stand up or look at the atom bomb. While we waited, I heard a senior officer approach and stop to talk with an officer, who was standing a little distance away. I heard the officer, who had been with us for the pre-blast preparation, ask the senior officer about handing out dark glasses to help protect the eyes of the troops. The senior officer simply responded, "When that bomb goes off, they don't need dark glasses. I am betting they will close their eyes."

Now that all the technical problems had been resolved, we were ready for the test. First, was the explosion of a typical bomb. They lit the match and off it went. Harry said his thoughts about that explosion were "not much." No one even hunkered down in the trench for that one.

Next came the show. We got down in the trench and when the big bomb went off the light was so bright it hurt. "It hurt with my eyes squeezed shut. I had them shut just as tight as I could get them and I could still see the shadow of the man in front of me. Even through my eyelids with my eyes shut tight." The blast wave went right over us. After a while I stood up and looked. The atomic cloud had risen to over 100,000 feet in front of us in seconds. The colors in the cloud were pinks and blues - very strange. I looked around and the trees that were behind us were on fire. That blast of fire had gone over the top of us and lit up every one of those trees. Now the officers began to call us out of the trench.

We were told to get up and walk around. Men with Geiger counters were around us and told us where we could walk and when to stop. The animals in the cages were all burned. Some of them were still alive. We walked around for some time, looking and taking in the scene until they brought up the trucks and rode us back to camp.

Questions to Harry came pretty fast after his talk. He reported as far as he knew he never suffered any ill effects from the experiment. He turned in his radiation badge and has never been contacted by the government about its reading, no follow-up testing and no medical examinations. Harry commented: "We went to the test, watched it and that was that. I am fine as far as I know. I am still here."

The meeting with Harry ended with one final question. Harry answered it as he turned off the microphone - "Nope, never have glowed in the dark." There you have it. If you were at the Fall Officers Conference and heard Harry Stowe tell this story, you were present for a piece of ski patrol history. If you missed it, Harry just might fill you in with some of the details in his quiet, unassuming way. Those of us who heard Harry are betting, even if he starts to glow a little; he won't admit to it.
